



## Client Bill of Rights

**Contact Information:** My name is Joseph Nunan CH, CI, DBA Chester County Hypnosis. I can be contacted through my office 3001 Stoneham Dr., West Chester, PA 19082 or by telephone at 610-296-4929.

**Education and Training:** I am fully trained and accredited Certified Hypnotherapist and Certified Instructor of the National Guild of Hypnotists and complete annual continuing education to maintain my training at the highest levels. The National Guild of Hypnotists is the oldest and largest hypnotism organization in the world and its certification is the most widely recognized credential for the professional practice of the hypnotic arts.

**NOTICE:** As the Commonwealth of Pennsylvania has not adopted formal education and training standards for the practice of Hypnotism or Hypnotherapy, this statement of credentials is for information purposes only. Hypnotism is a self-regulating profession and its practitioners are not currently licensed in Pennsylvania. I am not a physician nor a licensed health care provider and may not provide a medical diagnosis, medical treatment nor recommend discontinuance of medically prescribed treatments. If you desire a diagnosis or medical advice or treatment of any type, you may seek such services at any time from a licensed healthcare practitioner. In the event my services are terminated by a client, the client has a right to coordinated transfer of services to another practitioner. **Redress:** I am a certified member of the National Guild of Hypnotists, and practice fully in accordance with their Code of Professional Ethics and Standards. If you have a complaint about my services or behavior that I cannot resolve for you personally, you may contact the National Guild of Hypnotists at P.O. Box 308, Merrimack, NH 03054-0308, (603) 429-9438, to seek redress. Other services than my own may also be available to you in the community. You may locate such providers in the telephone book.

**Fees:** The standard charge for my services are \$175/hr. Payment in full is required at time of service. You will be given 10 days notice of any change in fees.

**Confidentiality:** I will not release any information about you to anyone, for any reason, without a written authorization from you, except as provided for by law. You have a right to be allowed access to my written record about you.

**Insurance:** In general, although many of our services help our clients to lead healthier lifestyles, many insurance companies do not cover hypnosis services, and I caution you not to expect them to do so.

**Referral:** Clients may be asked to provide a referral from their physician or health care professional.

**My Approach:** My services and products are all directed towards helping my clients receive all the positive benefits possible from hypnosis.
